99TH DEPARTMENT OF NY VFW AUXILIARY CONVENTION

The 99th Department of NY VFW Auxiliary Convention was convened at 8:00AM by Past Department President Nina LeFrois and the Officers completing the Cross of Malta under the leadership of Conductor Charlene Carnright and Assistant Conductor Jackie Cosh. Attendees were welcomed and President Rose was presented with her Convention badge. Nina then turned the meeting over to President Rose Cooper.

The President told Madam Conductor, it would not be necessary to check current dues cards, as each member had been checked at the door by the Guard and Assistant Guard as they entered the room and were in possession of their conference badge.

Memo from National dated 4/17/24 the Department of Illinois Secretary resigned for health reasons. The Department President has appointed Rhonda Borkgren to the position. Update your National Directory.

Memo from National dated 5/10/24 PNP Evelyn McCune has moved from FL back to her home state of Kansas.

Memo from National dated 5/20/24 Department of North Dakota President Alice Benson passed away following surgery.

Memo from National informing that the National Director of Administrative Services, Janice Criswell passed away unexpectedly on May 22, 2024. Janice had worked at the National Headquarters for more than 20 years and her loss will be immeasurable.

Memo from National dated 5/28/24 The family of Janice Criswell will be holding a private family-only funeral for Janice in Hill City KS. Saturday, June 8, 2024
