Auxiliary President, all necessary forms are enclosed in this mailing for you to complete for the 2021-2022 year. Be sure to read Department Secretary Debbie Cenni's letter and follow directions on each form. Election of Officers and Delegates (and Alternates) shall be held at your **April** meeting. **Auxiliary Secretary**, you should return the **Anticipated Report of Auxiliary Officers and Department Delegates to the Dept Secretary** immediately following elections. ***PLEASE DO NOT HOLD THESE FORMS UNTIL YOUR INSTALLATION!***

National, Department, District and County Council Delegates each has its own form. Delegate forms should be sent to the appropriate secretary, as indicated on each form, immediately following your elections in April. National Delegates may be entered directly in MALTA or mailed to the Department Secretary – she will enter them for you. Delegate strength is based on current membership. ***Please read and follow the directions on each Delegate form.***

The **Warrant to Install Officers and Installation Report** is one form. This form is **NOT** found on any website! It shall be sent to the Department Secretary immediately following Installation of Officers. **Note: Election of Officers and Installation MAY be held at the same meeting!** Ensure that the Installing Officer is qualified and he/she signs the Installation Report. You should keep a copy of all forms. Ensure accuracy as the Department and National organizations obtain Officer contact information from these forms.

Districts and County Councils elect and install officers at its respective Convention. The District/County Council Secretary shall return the Election of Officer and Installation Report to Department Secretary Debbie Cenni immediately following the convention.

Deceased member names for the Department Memorial Service are obtained in MALTA. Auxiliaries should enter names of deceased members in MALTA or report them to the Department Secretary or Department Treasurer.

Also enclosed in this packet is a 45+ year member form. Treasurers must review membership applications or minutes to locate the date a member was accepted into the Auxiliary. There is NO report available in MALTA to obtain 45+ year member names. USPS names of 45+ members to **Debbie Casella, PDP** no later than May 1, 2022. Certificates will be printed for those members.

Year-end program reports must be received by respective chairmen on or before April 1, 2022. Due to high mail volume causing delays in delivery, Auxiliaries are encouraged to email Year-end reports or allow five (5) days for USPS delivery. Forms are found in the Guidebook and on the Department website (www.vfwauxny.org). Your Auxiliary must submit a Year-end report to be eligible to receive program awards. Do not write "nothing to report" on the forms. You have all done something to earn credit for each and every program! Contact the respective chairman or Department Secretary Debbie Cenni if you need assistance!

Auxiliary, County Council, and District President year-end report forms are also in the Guidebook. For President's to be eligible for awards, **Year-end reports must be emailed or postmarked no later than April 10, 2022. Due to high mail volume causing postal delays, allow five (5) days for postal delivery.**

Dear Auxiliary President and Secretary,

Enclosed is *Anticipated Report of Auxiliary Officers* and *Warrant to Install Officers and Installation Report* for 2022-2023. *These forms are also found on the Department website www.vfwauxny.org. Please – read and follow instructions on each form and adhere to deadlines!* Delegate/Alternate forms for each level are also enclosed. *Election of Officers and Installation MAY be held at the same meeting in April!*

→ **Bylaws Sec. 804A—Election—Auxiliary** • Elective officers shall be nominated and elected at a regular business meeting in April. *Delegates/Alternates are also to be elected at your April meeting.* Delegate strength is based on membership in good standing as of the *date of election.* Refer to **Bylaws Sec. 301 to Sec. 308** and follow the directions.

→ The Auxiliary Secretary shall return the *Anticipated Report of Auxiliary Officers and Department Delegates/ Alternates* to Department Secretary Debbie Cenni *Immediately Following Election of Officers in April* even if you enter the information in MALTA! *PLEASE – DO NOT hold these reports until Installation!*

→ The Auxiliary Secretary shall read the *Warrant to Install Officers and Installation Report at the time of Installation.* Refer to **Bylaws Sec. 806—Installation**. Ensure the Installing Officer is a member in good standing and he/she is eligible to install officers. The Installing Officer *must sign where indicated* and include his/her highest elected office ever held (ie. Past Post Commander, Past District President, Past Auxiliary President). Return *Warrant to Install Officers and Installation* to the Department Secretary immediately following Installation of Officers *even if the Auxiliary Secretary has entered the information in MALTA.* As a convenience, Department Secretary Debbie Cenni will enter Officer information in MALTA.

→ **Neatly Print Information and check for Accuracy ... Especially Membership Numbers and Email Addresses!**

→ **Bylaws Sec. 802—Elective officers and Bylaws Sec. 803—Appointive Officers**

→ *The President (elected), Secretary (appointed), and Treasurer (elected) CANNOT also hold the office of Trustee!*

Be sure: • Membership Number is accurate and is exactly as it appears on current membership card; • Address, telephone, and email information is legible; • Meeting location (address), day and time of meeting is current; • Current annual per member dues amount (that means how much *one* annual member pays your Auxiliary to renew annual dues).

→ Department, District and County Council (if applicable) Delegate/Alternate form shall be returned *immediately following election of officers in April* to the appropriate Secretary as indicated on each form. *Send this form to the appropriate secretary immediately following Election of Officers. Do not hold Delegate forms until your Installation!*

National Delegate/Alternates must include membership ID numbers. The Auxiliary Secretary may enter in MALTA or send to the Department Secretary who will enter the information. National Delegate deadline is May 31, 2022. No exceptions! National Delegate strength is based on your Auxiliary membership as of *March 31, 2022.*

→ In order for Delegates to vote at their Convention *ALL FOUR OF THE FOLLOWING CRITERIA MUST BE MET:*

1. Delegate/Alternate form must be returned to the appropriate Secretary no later than May 1, 2022;

2. Delegates/Alternates must show their current dues card to the Credentials Committee;

3. The Auxiliary in which the Delegate/Alternate belongs *MUST BE CURRENT WITH QUARTERLY AUDIT REPORTS (the last four audit reports must have been submitted;* (The Department Treasurer will contact Auxiliaries that have outstanding audit reports) *and*

4. the Delegate's/Alternate's Auxiliary must not have any outstanding financial obligation to National Headquarters.

→ Auxiliaries should record deceased members in MALTA or report names to Department Secretary Debbie Cenni or Department Treasurer Kim White prior to April 30, 2022. Only those names that have been recorded in MALTA from May 1, 2021 to April 30, 2022 will be included in the Department Memorial Service program bulletin.

→ Auxiliaries are encouraged to submit names of their 45+ year members to Debbie Casella, PDP by May 1, 2022!

There is no report in MALTA to find this information. You must refer to the election date found on the Auxiliary's copy of the membership application on file with your Auxiliary. Enclosed is the 45+ member form.

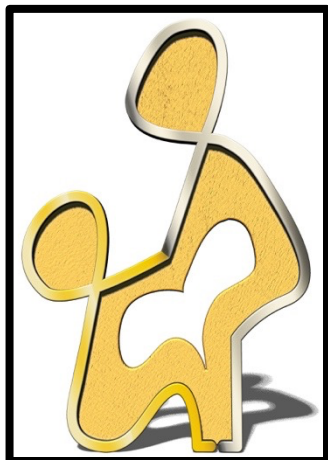
