Question 1 – Does each Auxiliary President need to attend all meetings called by their County Council or District? Ans. 1 – Refer to Bylaws Section 810A—the President or her/his representative *should* attend all properly called District and County Council (if applicable) meetings and conventions.

Question 2 – What is the website address for the VFW Auxiliary Department of New York?

Ans. 2 – The address for the VFW Auxiliary Department of New York Auxiliary website is www.vfwauxny.org

Question 3 – Can Red Cross Blood Drives held at the Post be reported for Auxiliary Community Outreach credit? Ans. 3 – Blood drives held at your Post Home *CANNOT* be considered for the Auxiliary Community Outreach Program. However, your donated time should be reported under Veterans and Family Support. In order for a blood drive to qualify to be reported under Auxiliary Community Outreach, it would have to be held at a facility, other than your Post, such as community center, senior center, etc.

Question 4 – I deliver Meals on Wheels. Can I report that for the Auxiliary Community Outreach Program? **Ans. 4** – Your time may be reported to the Auxiliary Community Outreach Program if the meals are NOT picked up at your Post.

Question 5 – Is there still planned a "Capitol Hill" Day in Albany the day before the Fall Conference? Ans. 5 – Yes! Program Chairman Belinda Cole is working

to have one 1 representative from each District attend.



Question 6 – Will there be Legislative material at Fall Conference for the members to contact their Legislators regarding the Global War on Terrorism Memorial Location Act and the Major Richard Star Act?

Ans. 6 - Yes! Material will be available for members to contact their Legislators on these two important bills.

Question 7 – What does REJOIN LIFE mean on the monthly Membership report?

Ans. 7 – *Rejoin Life* means an individual let their annual membership dues lapsed and are rejoining as a Life Member.

Question 8 – What does "an Auxiliary needs to have one project to benefit Veterans" mean?

Ans. 8 – Per the Circle of Excellence criteria in the National Guidebook, "All Auxiliaries MUST complete at least one project, activity OR donation that benefits Veterans by April 30, 2021." Report to V&FS Chairman Karen Mack.

Question 9 – How can I make a donation to Patriotism through Literacy Program at a local school?

Ans. 9 – Contact your local elementary, middle, or high school. Ask to speak to the principal. Explain that your Auxiliary would like to make a donation for books for the Patriotism through Literacy Program sponsored by the VFW Auxiliary. Ask what the best way is to send a donation: check, gift card or ask other ways to donate funds.

Question 10 – National announced there is a new uniform shirt. Do I need to purchase a new blue uniform shirt? **Ans. 10** – The blue uniform blouse/shirt that most Auxiliary members are currently wearing has been grandfathered in. There is no time limit that the shirt can no longer be worn. The marine blue uniform shirt can be worn forever!

Why are we doing inspections? To see what our Auxiliaries are doing and, more importantly, to find out if they need our assistance. Many Auxiliaries have had to think out of the box over the last year to fund programs that help veterans and families and to assist their communities. In the remarks section you can offer other ideas. If assistance is needed, we can mentor an Auxiliary. These are just a few of the reasons for official visits/inspections.

One form I received had no seal. I contacted the District President who told me that the Auxiliary has no seal. If this is the case please notate that on the form but also explain to the Auxiliary that all need to have a seal. It is a requirement when sending mail or forms to Department or National.

Inspectors, review the forms and be sure all questions are answered. Include comments about your visit in the remarks section. We want to hear about questions or problems and the good things the Auxiliary is doing. **Examine the checks to be sure proper signatures are there.** Send all three copies of the form to the District President within 5 to 7 days of the completion of your visit.

District Presidents are to appoint inspectors. When the forms are returned to you, review them and make sure they are complete. If they are not complete I will return them to you for completion. **Date the upper right hand corner** and return all copies to me within 5 to 7 days after you receive them. **DO NOT HOLD INSPECTIONS UNTIL YOU HAVE SEVERAL TO SEND AT ONE TIME.**

If a member cannot do an inspection, return all materials back to the District President and a new inspector will be appointed. The District President is the only one who can appoint an inspector.

Remember, though, it's not "one and done." Auxiliaries should have it in their Membership PLAN to have at least four drives per year. Membership plan? Yes! Every Auxiliary should have a plan for membership that includes: Contacting members, Outreach to former members, Recruiting events, and Choosing a mentor for new members.

Before the new membership year begins your Auxiliary should set its calendar and plan when to do these things, as well as recruit members of the Membership Committee. Use the tools at vfwauxiliary.org as you promote VFW and VFW Auxiliary membership in your community. Request The Fact Sheet from National Headquarters which is especially valuable. It spells out exactly what our organization accomplished in the last year. It's a great tool to show prospective members what "we" do.

As I write this, the Department of New York sits at the bottom of our Membership Division with 74.82% and only 30.25% of our annuals retained. Does that sound like a winning Olympic TEAM? Every member of a TEAM must do his/her part. EVERY AUXILIARY on OUR TEAM needs to do ITS PART. If your Auxiliary hasn't sent in any of your annual members yet, **PLEASE** do so. Do you have hospitalized, nursing home residents, seniors, or shut-ins who could use help paying their dues? You may tap into your Relief Fund to help them. Identify the members you can assist and remit their dues NOW.

Make sure your Annual members understand that while they are in "good standing" until December 31st, that doesn't mean they should wait until then to pay their dues. Consider incentives to promote earlier dues payment – a membership breakfast (or dinner) for early payers, or a drawing – for a life membership, gift certificate or a prize. You can be as creative as you want and I'd love to hear your incentive ideas when you report.

At the Fall Conference you heard me state that the Department MUST meet our GAIN (new/rejoined members) as well as our RETENTION (annual and annuals who convert to Life) by October 31st. I trust you, our TEAM, to have done your part in making that happen. Thank you for ALL you do! Loyally, Chris

Listed below are commonly asked questions to share with our members:

- Q. Are children permitted to attend Auxiliary meetings?
 A. Yes! Children are allowed to attend meetings if accompanied by an Auxiliary member. See Bylaws Sec. 909
 Q. Are alcoholic beverages permitted during the Auxiliary
- **A.** No alcoholic beverages will be permitted during Auxiliary meetings. See Bylaws Sec. $902 4^{th}$ bullet
- **Q**. Are members able to order items from the VFW Store?
- **A.** Auxiliaries, County Council, District, Department or Auxiliary members may order from the VFW Store using the procedures provided by the VFW. See Bylaws Sec. 914.
- **Q**. How long is the Auxiliary Charter draped when a member passes away?
- **A**. The Charter should remain draped for a period of thirty (30) days.
- Q. What are the meaning of the Raps of the Gavel? A. One (1) rap of gavel – Attention; Two (2) raps of the gavel – Rise; Three (3) raps of the gavel – Be Seated

I hope that you will find the "*Did You Know*" Zoom training sessions informative. All questions and answers from the "Did You Know" training sessions will be shared on the Department website and in the *Auxiliary News*.

AUXILIARY COMMUNITY OUTREACH (ACO) FREQUENTLY ASKED QUESTIONS

- 1. Q.: Every year my Auxiliary participates in a walk in our area that raises awareness about suicide prevention. Members walk in the event and donate \$100 to the organization. Can the number of hours and members who walked in the event count toward Auxiliary Community Outreach?
- A.: This is a great team-building activity for your Auxiliary, however, walking or running in an event/race may not be reported under Auxiliary Community Outreach. This particular example may be reported under Veterans & Family Support as that's where Veteran & Military Suicide Awareness and Prevention falls.
- 2. Q.: Members of a local Auxiliary were asked to sit on their county board to help raise money and volunteer to work at a dedication of a memorial that honors veterans. Since it was not a VFW or VFW Auxiliary-sponsored event, can this be reported under Auxiliary Community Outreach? A.: No, it cannot be reported under ACO. It's for veterans and the betterment of the community, therefore, it should be reported under Veterans & Family Support.
- **3. Q.:** A VFW Post hosts several events throughout the year at which VFW and Auxiliary members hand out Thin Blue Line flags in honor of police officers. Can this be reported under Auxiliary Community Outreach?
- **A.:** No, it cannot be reported under ACO as it is not in partnership with another organization. If the Auxiliary partnered with the police department or police foundation to hand out Thin Blue Line flags it would count under ACO.
- **4. Q.:** A few of the ways listed to participate in Auxiliary Community Outreach involve youth. Would this be reported under the Auxiliary's Youth Activities Program? **A.:** It depends on the project. For example, if you are putting on a patriotic program at a school with your Auxiliary, that is reported under Americanism and/or Youth Activities. If your Auxiliary partners with the Girl Scouts or Boy Scouts to teach them the Folds of the Flag, that is reported under Americanism and/or Youth Activities. If your Auxiliary volunteers at the Boys & Girls Club to tutor a group of children that is reported under Auxiliary Community Outreach.
- **5. Q.:** Our Auxiliary purchases and delivers turkeys for a food pantry every Thanksgiving. Does this get reported under Auxiliary Community Outreach?
- **A.:** No! Dropping off turkeys for a Thanksgiving meal is not the same as volunteering time in the food pantry organizing food, serving meals, bussing tables, etc.
- **6. Q.:** Our Auxiliary partners with another organization to host a sock collection at our local Walmart. Does this qualify as Auxiliary Community Outreach?
- A.: It depends. If you stay and man the collection, then yes. If you drop off a collection bin and leave, then no. If you are unsure of whether your project for will count toward the Auxiliary Community Outreach Program, contact your Department Chairman [Judy Lefebvre] with your questions.



Pay special attention to the Action Alerts which need your immediate support. Items such as the:

GWOT Memorial Location Act NOW is the time to formally honor the more than 2.7 million men and women who served in the Global War on Terrorism (GWOT). With the recent end to the conflict in Afghanistan and the 20th commemoration of the attacks on 9/11, Washington bureaucrats are prohibiting a GWOT Memorial on the National Mall. The VFW believes our veterans, their families and survivors have earned their right to have a place to commemorate alongside the other memorials of previous generations. Congress is failing the post-9/11 veterans who fought to defend our freedom and way of life.

Major Richard Star Act Many disabled combat veterans are being DENIED full access to their hard-earned benefits. Over 48,000 medically retired veterans, most Purple Heart recipients, do not receive full retirement pay — they sacrificed their health and military careers. The VFW firmly believes DOD retirement pay and VA disability compensation are fundamentally different benefits, earned for different reasons. Congress fails to acknowledge this inequity. They need to fix this injustice now.

The VFW demands that Congress pass both the GWOT Memorial Location Act and the Major Richard Star Act as amendments to the NDAA for 2022. *Let our voices be heard*! If it is important to our Veterans then it is important to us! WEARING THE OFFICIAL CAP

In the absence of procedures in our Bylaws for wearing the Official Cap, National President Jean Hamil has issued the following ruling (which supercedes then National President Sandi Kriebel's ruling dated June 28, 2019):

"If you choose to wear the Official VFW Auxiliary Cap, it will remain on your head for TAPS, the Pledge of Allegiance and the National Anthem. Caps will be removed for the prayer, <u>IF</u> the VFW or Auxiliary Chaplain removes their cap and/or <u>IF</u> the Auxiliary Chaplain is not wearing a cap."

Other information pertaining to the caps:

- 1) If uncovering, the hat shall be placed on the extended closed fingers of the right hand in such a way that the Cross of Malta is exposed and held over the heart; the left hand goes behind the back as in parade rest.
- 2) Official caps will NOT be worn during luncheons, banquets or other meals.
- 3) If you are unable to see the Chaplain and are unsure if they removed their cap, please remove your cap.
