The holidays are approaching quickly. Stumped for that perfect gift idea? Why

not consider a gift of giving? Give that person who is difficult to shop for a Life Membership in the VFW Auxiliary. Think about the legacy members who your Auxiliary might have already been paying their annual per capita, perhaps for a long time now. Give that member a life membership. It pays for itself over time, both by eliminating the annual per capita your Auxiliary pays and through the pay back from National to your Auxiliary for EACH life member you have.

We gave it a good shot, but as of this writing, we reached our first quarter Department goal, but not our retention goal. With only three more days and needing 953 retained annual members, I expect we might be a little short ... but well on our way to retaining 75% by January 31st. So don't give up. The Games are still on!

There were 63 Auxiliaries that reached 85% membership by October 15th. They were all entered into a drawing to win the Vaulting into the Membership Year Award. The lucky winner was VFW Auxiliary to SSG Michael Ollis Auxiliary to Post No. 9587 in District 2. Congratulations! They will receive a check for \$50.00 from the Department Treasurer. If they had retained 50% of last year's annual members, they would have received an additional \$50.00. However, they were 37% retained on October 15<sup>th</sup>.

The Rounding the Bases Award for any Auxiliary attaining 95% membership is due by November 30, 2021. If the winning Auxiliary has also retained AT LEAST 75% of their annual members they will be in to win \$100.00 for their Auxiliary. Every Auxiliary can use that extra money with the holidays coming. It might be just what is needed to help adopt a Veteran family for Christmas or provide a shut-in with a Thanksgiving dinner.

Since this newsletter is the last one until after the holidays, I must remind all to look in the Guidebook. The deadlines for eligibility to win the Worth Your Weight(lifting) Award (100% membership – 98% retention) is December 31st and the Shooting for the Bull's Eve Award (100% retained AND 5 new or rejoined) is February 28, 2022. Check out the neat award for the Bull's Eve winner.

Be sure to report if your Auxiliary President attended ZOOM OTI and/or Fall Conference. Nearly half of our Auxiliaries were on ZOOM, and there were 172 + members registered for Fall Conference, yet only 7 have reported. Look at what is asked on the Year-end report. Be sure to keep track of the methods used to collect dues.

All Auxiliaries on all levels are also requested to provide membership trainings. Start planning them now and report them before March 1, 2022 to receive your Silver Olympic medals at the Spring Conference in Binghamton.



There were 7 events and 77 participants. Today, the **National Veterans Wheelchair Games** has over 500 participants, competing in 22 events. As you can see, the games have grown to an amazing level.

Wheelchair Games are open to all **U.S. Veterans** with spinal cord injuries, amputations, multiple sclerosis or other central neurological conditions that require wheelchairs. These games have become more popular as therapists are turning to engage Adaptive Sports to help Veterans become more active and gain more confidence and raise self-esteem.

The games help to maintain body weight, combat chronic health conditions, boost energy levels and ensure healthy rest and sleeping patterns. The games also help reduce anxiety and depression by giving the Veterans new experiences and new friendships.

The 2022 Games will be held July 7-12, 2022 in Tempe, AZ. Unfortunately, due to the pandemic, the 2021 New York City Games were not held! Please keep all Veterans in your thoughts and prayers as we enter the New Year!!

#### **BYLAWS RESOLUTION - PASSED**

A resolution to amend Bylaws Sec.101—Eligibility was adopted at the 108th National Convention in Kansas City.

This change removes the requirement that an individual must be a citizen of the United States or a United States national from Auxiliary eligibility requirements.

As of September 1, 2021, the amended Bylaw reads: Membership in the VFW Auxiliary shall be limited to: husbands/wives; widowers/widows; fathers/mothers; grandfathers/grandmothers sons/daughters; grandsons/ granddaughters brothers/sisters of persons who were or are eligible for membership in the Veterans of Foreign Wars of the United States. They must also:

- Profess a belief in God
- Be not less than sixteen (16) years old.
- Any current VFW member or any person eligible to join the VFW shall not be eligible to join the Auxiliary.
- Women who joined the Auxiliary prior to August 21, 2015 who are current members or are eligible for membership in the VFW shall be eligible for the Auxiliary so long as their membership remains current.

Activities need to be approved and recorded in the Auxiliary minutes, volunteers must wear items that easily identity them as VFW Auxiliary members, activities that are reportable to other Auxiliary Program Chairman <u>cannot</u> be reported as Auxiliary Community Outreach (i.e. hospital and nursing home hours must be reported to Hospital Chairman and activities serving/honoring Veterans must be reported to Veterans & Family Support.).

Report members and hours only – Do not report cash, gifts or other "like" monetary donations.











Coordinate with ... another community organization to collect, sort, package, wrap and/or deliver food, clothes, toys.

- ... the town and local churches to host a holiday party with caroling, snacks and gifts from Santa at a local senior center.
- ... the Assistance Bureau or local food pantry to sort, package and deliver food as well as toys to needy families.
- ... the homeless shelter to cook and serve Thanksgiving and/or Christmas Dinner.
- ... the Christmas Bureau to contact and pickup donated items from local retail and other business locations.

**Remember** – activities cannot be held at your local VFW but you can use other locations in the community such as: the town hall, church basement, senior center recreation hall.

- **Q.** Where can I find the responsibilities of Trustees? **A.** Refer to: Bylaws Sec. 814—Trustees, Duties of (All Levels); Booklet of Instruction (yellow pages) Trustees; and in MALTA [under Resources] *Building on the Auxiliary Foundation Guidebooks for Officers, Chairmen and Members* Guidebook 5 Financial Responsibilities Trustees pages 9 to 13.
- **Q.** Is there a special order that Official Communications should be read at a meeting?
- A. Refer to the Booklet of Instructions (yellow pages) Secretary Minutes Reading of Official and Other Communications. •All communications are grouped under one heading but National letters are read first, Department General Orders and letters [President's letter in the *Aux. News*] second, followed by District communications, County Council, Post or other Auxiliary communications and finally thank-you notes, cards and communications from outside organizations.
- **Q.** How much info should be included in minutes? **A.** The minutes are a record of business transacted during a meeting, not what was discussed.

- **Q.** Is it acceptable to distribute copies of the Department President's letter (*Aux. News*) rather than read it aloud at the meeting? **A.** The President's letter and General Orders are Official Communications and should be read at an Auxiliary meeting.
- Q: What is the suggested practice for filing correspondence with minutes, separate file separate tab within minutes binder?

  A. Refer to Booklet of Instructions (yellow pages) Record Retention Guide. Correspondence, general 1 year. The Department Secretary suggested filing correspondence with the minutes each month in the same binder using a separate tab.
- **Q.** Is the Secretary responsible for keeping track of the events and filing the paperwork to confirm?
- **A.** The Chairman of an event is responsible for reporting to the Auxiliary and providing a report to the Secretary to be filed with the minutes. The Secretary is not responsible for compiling the detail for such reports.
- **Q.** What is the procedure for contacting Auxiliary members pertaining to a Special Meeting?
- **A.** Refer to Bylaws Sec. 210—Meetings, Regular and Special. Members who have provided the Secretary with a valid email address may be notified electronically.
- **Q.** Who should update member contact information in MALTA? **A.** The President, Secretary and Treasurer have access to edit Auxiliary member information in MALTA. Work together as a team to maintain up to date member contact information! It is also important to record deceased members in a timely manner.
- Q. Can an Auxiliary member make updates in MALTA?
  A. If a member has Activated an account in MALTA, he/she may edit his/her own contact information except date of birth.

Hello Brothers and Sisters! I hope that everyone participated in the many hometown local elections in November. Electing the proper representatives will give us the best chance of assuring that our Veterans and their families will be taken care of. Remember to familiarize yourself with the VFW and Auxiliary legislative interests (Priority Goals). Our National VFW legislative team has done all the leg work for us and all we must do is sign up for the *Action Corps Weekly* e-newsletter. But don't just sign up for it, open it, read it and share it with your members.

In the October 25<sup>th</sup> *Action Corps Weekly*, the House Veterans Affairs Subcommittee met to discuss pending legislation. Such as: **H.R. 2568** U.S. Cadet Nurse Corp (CNC) Service Recognition Act of 2021. The CNC was formed on July 1, 1943 to address the nation's nursing shortage during World War II. Nearly 180,000 women from across the U.S. responded to the call to serve their country in uniform for the CNC during this critical time of need. The VFW supports this legislation to honor these service members as Veterans, making them eligible, specifically, to receive a grave-site plaque and an American flag for their wartime, active-duty service but it would not grant Department of Veterans Affairs (VA) benefits, other financial benefits or burial at Arlington National Cemetery. It is time to finally recognize these Americans for their honorable World War II service.

**H.R. 4601** Commitment to Veteran Support & Outreach Act. The VFW supports the intent of this legislation to improve outreach to Veterans regarding the VA benefits to which they are entitled. We see this as a duty of the Department, with the help of Veterans Service Organizations (VSOs) and partners, to continuously seek to improve communications and outreach to Veterans regarding their earned benefits, health care, and other services.

This Action Corps Weekly e-newsletter contains everything you need to EDUCATE, PARTICIPATE AND GET OTHERS INVOLVED with the legislation that is affecting our Veterans. Share the link: www.vfw.org/advocacy/grassroots-efforts, click on Action Corps Button, enter your email and zip code.



In that same October 25<sup>th</sup> newsletter, we were updated that one of our local MIA/POW's was found. Army Cpl. Robert C. Agard, Jr., age 19, of Buffalo, NY, was assigned to 2nd Platoon, 24th Reconnaissance Company, 24th Infantry Division. He was reported MIA on July 19, 1950 while conducting a night recon patrol with his unit near Tejon, South Korea. Following the war, his remains could not be identified. He will be buried May 30, 2022, in Elmira.

Here we are nearing the January 15<sup>th</sup> deadline for doing the official visit and inspections. I hope all visits are now scheduled and are being completed. There are several districts that have only completed a few and sent them to me. One or two have them almost completed and there is one district that has not completed any! The weather is changing and the holidays are approaching so please get these done.

All Auxiliaries should have had their 990's filed by November 15<sup>th</sup>. If an Auxiliary has not filed their 990-n, please put them in contact with Kim White to find out what they need to do ... but indicate the last date of filing on the Official Visit form.

The question about an admission fee. This is what a new member pays in addition to what the regular dues amount is. It is NOT the dues amount plus the fee. If none is charged then check the box for none or indicate -0- amount.

District Presidents are to appoint inspectors. When the inspection forms are returned to you, go over them and make sure they are complete. 

I'm Keeping an Eagle Eye on the Eagle's Nest

Technology is a wonderful thing. Of course, technology can have its ... hiccups. Sometimes, the problem is more human in nature—like when you forget to unmute during a Zoom meeting. Then there's email. Like any technology, email "bugs" are user errors. Sometimes using the "reply all" function is necessary – and sometimes, not!

You're probably thinking you should <u>avoid the reply all button at all costs</u>. That's hardly the case. You should often skip reply all, but there are times when reply all is the right move. <u>The Trouble with Reply All</u> depends on the topic or your response. Hitting reply all isn't always the best. In some cases, it creates more trouble than it's worth. There's a chance you're including people who no longer need to be included in the email chain and wasting their time with each new email. Sometimes someone on the chain has a side thought about the conversation. In attempting to share it with one or two people on the chain, they accidentally hit reply all.

Mass emails are not uncommon in professional settings, like an invitation to a company-wide meeting. You may need to let the organizer know you can't attend. Unless you're in charge of the meeting, the rest of the attendees don't need to know that.

Some think that everyone should be on every email, even when that's not the case. Don't ask if you're supposed to be included. That only creates a longer response chain and more confusion. Instead, mute the emails (if you can) or ignore them, and reach out to the sender directly to get clarification.

There are many reasons not to use reply all, but there are times when reply all is useful. Follow proper reply all email etiquette. When in doubt, ask yourself if your response adds value to the conversation. If not, consider skipping the response. Using reply all is one way to end a reply all chain. For example, if someone sends out a company-wide email asking about a particular spreadsheet or question, and you've got the information or the answer, replying to everyone with, "I've got it and will send to you directly" can stop the rest of the recipients from replying all with, "Not me," and/or "I don't know."

If the sender instructs you to reply to all then hit reply all without any fear or worry (make sure you're following proper email etiquette). Read emails carefully! Sometimes the sender asks "reply only to me."

You may need to reply to some, but not all, of the recipients. In that case, you should hit reply all to retrieve only those email addresses and delete those who don't need to see a response.

We've all messed up on email. Sometimes, it's a reply all mistake. What if you didn't mean to reply all? Before hitting send on any email, double-check to make sure you've selected the right option. You may have thought you hit reply but hit reply all. It happens!

<u>USE REPLY ALL WISELY!</u> Email is a powerful communication tool. Every email we send should be sent in a professional manner.

It is an honor to serve as Department Historian/Media Relations Chairman this year and will do so with much excitement!



Maybe this year with all the uncertainty around delivery dates, it is a good time to give the gift of remembrance that will deliver memories for years to come to those on our shopping lists. A wreath placed in honor of a family, or even a child, is an opportunity not only to remember someone who served but to teach history in a way that becomes very personal.

I learned from my mother's present years ago that the lesson and story behind the gift can be more meaningful than the gift itself. In the same way, laying a veteran's wreath not only is a gift of remembrance but an opportunity to teach and share stories of service and sacrifice.

Taking young people to the gravesite of a veteran and saying their name is something that will stay with them forever. I know my husband Morrill - WAA's founder - first visited Arlington National Cemetery at the age of 12, and he never forgot.
