Sec. 109–Members and Officers—Rights of • ...reasons an officer may be relieved of their office: •Non-payment of dues. Please make sure all officers and members pay their dues and are in good standing! The Relief Fund can be used to help anyone who may be experiencing hardship.

DID YOU KNOW? – Role of Investigating Committee November 22, 2021 – Questions and Answers

Q1. What does the Investigating Committee do with a DD214 once it completes reviewing a new member application? Ans. The DD214 must be returned to the Veteran or the person who submitted the application.

Q2. Where can an applicant obtain a copy of the DD214? Ans. Visit the National Personnel Records Center (NPRC) at *vetrecs.archives.gov/ or archives.gov/veterans/military-service-records/*

Q3. What other resources can help to obtain a DD214? Ans. •The County Veterans Office in your county office building. You may need to make an appointment.

If a military funeral was performed or a Veteran's headstone was ordered, the funeral director had to verify military service.Check with your VFW Post. The Veteran may have been a VFW member, and the Post may have the information on file.

Q4. What does a Veteran's widow/er need to do to join? Ans. See Bylaws Sec. 102—Application—New Member Second bullet – Applications must be accompanied by •Proof of VFW membership of person in whose right the application is made. If the widow/er can provide the veteran's VFW membership card, the applicant should be eligible to join. The Post Commander or Quartermaster may be able to confirm the eligibility information. Indicate **"non-affiliated"** since the veteran is deceased.

Q. What is "Post Affiliated" and "Non-Affiliated"? Ans. **"Post Affiliated"** – the **veteran is a current VFW Post member** affiliated with the Auxiliary the applicant is applying to. **"Non-Affiliated"** – the **veteran is not a current VFW Post member** affiliated with the Auxiliary the applicant is applying to. This includes Post members who are deceased.

Q. Who may join the Auxiliary based on the Eligibility Wheel? Ans. Eligibility is governed by the IRS. The veteran and prospective member must have a familial relationship within two generations. Please note: Step, half and adopted family members DO meet the standard set forth by the IRS.

Refer to Bylaws Sec. 101—Eligibility —Husbands/Wives, Fathers/Mothers, Sons/Daughters, Brothers/Sisters, Widows/ Widowers, Grandfathers/mothers, Grandsons/daughters. Note: Great grandchildren, aunts, uncles, nieces and nephews of the eligible veteran DO NOT meet the familial relationship.

Q. What is a DD214?

Ans. It is a complete and thorough document that verifies a service member's proof of Military Service typically issued by the Department of Defense at the final out-processing prior to retirement or separation from active service. The DD214 identifies the Veterans condition at time of discharge: honorable, general, other than honorable, dishonorable or bad conduct.

Q. What qualifies a service member to receive a DD214? Ans. The DD214 captures periods of continuous active-duty service accomplished from start to finish of active-duty through release date. One is considered a veteran if they were deployed for at least 180 days and were honorably discharged.

Q. Does having a DD214 make you a Veteran?

Ans. The DD214 is proof of discharge after being deployed under federal orders. If discharge was due to reasons other than dishonorable then one is considered a Veteran. DD214's were issued to all military services since January 1, 1950. Similar forms were used prior to January 1, 1950.

Q. How can one obtain a copy of a DD214 to join the VFW or Aux.? Ans. If you are the next of kin of a deceased veteran, show proof of death of the Veteran such as a copy of death certificate, letter from funeral home, or published obituary. DD214's can be requested online or via USPS mail. It takes 3-4 weeks to process your request.

Q. Why the history of a DD214?

Ans. Carefully read Article I Membership in the Bylaws. The DD214 is used to determine if one is eligible to join our organization. The Veteran must have served in a foreign war, insurrection, or expedition, which is recognized by the award of a campaign or service medal of the United States. Carefully read the Bylaws. Those who served in Korea and those who earned Hostile Fire or Imminent Danger Pay is outlined in the bylaws and ritual.

Q. You have a new member application to review. What is next? Ans. The investigating committee compares information on the DD214 with the service branch, qualifying dates and campaign medals with the bylaws to determine an applicant's eligibility.

DID YOU KNOW? – Role of Trustee DECEMBER 6, 2021

Q. Where can I find "<u>Building on the VFW Auxiliary Foundation</u>"? Ans. This document is found on the Department of New York VFW Auxiliary website under the Resources tab: www.vfwauxny.org and the National website at: www.vfwauxiliary.org/resources Refer to Guidebook 5 – Information for Treasurers and Trustees.

Q. Can an Auxiliary accept 'Zelle" donations? Ans. No!

Q. Does the President stop the Auxiliary meeting once the Trustees have received receipts for review/approval from the Conductor/ress? Ans. The President should continue the meeting without delay.

Q. Can Trustees review/approve multiple receipts? Ans. Trustees should review and approve each receipt. Receipts should note the purpose and cost of each item.

Ex: Receipt #1 - Stamps and envelopes for dues notice mailing. R #2 - Halloween candy, treat bags, drinks, and napkins – Children's Halloween Party; R #3 - Paper products for Veterans Day Dinner. The Conductor/ress should bring the receipts to the Treasurer once reviewed and signed by the Trustees. • Under "**Report of Trustees**" (after New Business), a motion is required to approve/pay the bills.

Q. What are Standing Rules?

A. Refer to Bylaws Sec 211—Standing Rules (Auxiliaries, County Councils, Districts, and Departments) Standing Rules allow the Auxiliary to do business between meetings. They need to be clear and concise and answer "what if's." They shorten meeting time since Standing Rules disbursements do not need to be approved during the meeting. They should be reviewed annually and amended if needed. The President, Secretary, and Treasurer should have a copy of the current approved Standing Rules.

Here are a few examples of Standing Rules:

• Auxiliary will provide financial aid to an Auxiliary member in good standing upon approval of the Trustees. The amount shall not exceed \$100 during the Auxiliary year (July – June).

Kitchen Chairman may spend up to \$100 per month to purchase food and/or kitchen supplies for Auxiliary events. Receipts must be provided at the next Auxiliary meeting to receive reimbursement.
The Auxiliary may donate 25¢ per member to Health & Happiness based on the June 30th membership.

<u>Outreach</u> – Auxiliary members reaching out and being visible as they partner (under the direction) with other organizations to improve the community including any group of people; such as: youth, senior citizens and/or those with disabilities. Activities that benefit the entire community and not one particular church, or one specific neighbor or one specific family in distress. Communities can be rural, suburban, urban, small or large.

<u>Volunteer Service</u> – Auxiliary members of any age donating their <u>time</u> (time only) to work together with another organization on projects that benefit any group of people, animals, the environment or public spaces while members are wearing identifying Auxiliary apparel. It is only <u>time</u> that is partnered with another organization – <u>NOT</u> donations of cash, food, homemade gloves, sweaters, blankets, new clothing or gift cards, etc.

<u>Report by the 1st</u> – Members and time spent that was approved and recorded in the Auxiliary minutes, including activity details about partnering organizations. *Activities* <u>CANNOT</u> be reportable under another Auxiliary program. <u>Report by the 1st</u> – Projects recognizing and honoring First Responders and essential workers.

Submit to Department Chairman by March 31st 8"x10" photo or collage of Auxiliary members volunteering with First Responders at a community activity and/or event. Criteria and entry form (required) are available on the National website: vfwauxiliary.org/resources or by contacting me. Auxiliary year-end report must be received by April 1st for collage to be judged.

<u>Submit by April 1st</u> – Auxiliary Community Outreach Program Year-end Report (see Guidebook or Dept website). <u>**Report to VFW Post Adjutant</u>** – All activities to be included on the Post Community Service Report.</u>

The following do Not Qualify for ACO Program Credit ...

Auxiliary activities at the Post. Most of those activities can be reported to other Auxiliary program chairmen.

■ Time donated at hospitals, long-term care, nursing homes and number of hours making homemade items. That time should be reported to the Hospital Chairman or Veterans and Family Support Chairman. Activities assisting veterans and their families and veteran memorial tributes should be reported to the Americanism or V&FS Chairman.

The holidays are behind us and it's time to get back to the business of membership. I want to thank the 49 Auxiliaries that were 95% or better before the November 30th Department deadline. As of this

writing, there are 24 Auxiliaries that have already hit the 100% or better mark! Thank you for your hard work.

Congratulations to Pine Valley Memorial Auxiliary No. 2522 in District 6. They won the \$100 drawing for the "Rounding the Bases" award -95% membership and 75% retained by November 30th. They were 98.98% with over 86% retained.

The "Worth Your Weight(lifting)" award deadline was December 31st. Auxiliaries that were 100% with 98% of their annual members retained were eligible for the drawing.

We all have those annual members who have not renewed their dues yet. PLEASE reach out to them. Their dues card was for 2021. 2021 is now gone and they are not in good standing. They are not eligible for any Auxiliary benefits from attending a meeting, applying for a cancer grant or club privileges – if your Post is a "members only" post. They have until June 30th to get back into good standing. But what if one of those members receives a dreaded diagnosis of cancer before that? Let's not let that happen to any of our members. If COVID, or some other adversity has affected one's ability to pay, please consider using your Auxiliary Relief Fund to help them.

Don't forget to schedule – and REPORT the details – your Membership trainings. These must be reported by March 1st to receive your silver Olympic medal at Spring Conference. County and District Presidents, 50% of your Auxiliaries need to report this in order for you to receive your silver medal.

The last update I had from my National Ambassador, we only needed 305 annual retentions by January 31st to meet the National Program goal. This is definitely attainable.

You've done a great job recruiting those new members! Thank you. Now, please take a few moments to mentor them as they attend your meetings. Have a "seasoned" member sit near them and explain what's going on. Hand out the sheet explaining the Auxiliary acronyms. Above all, INCLUDE them and encourage them to express their ideas and ask their questions. If we want them to keep coming back, we need to consider them "our best customers" and treat them as such.

As previously promised, I am highlighting another aspect of National Veterans Competitions – **The National Veterans Creative Arts Festival**. The first festivals were initiated in 1981 by Shirley Jeffries, a recreational therapist, in Waco, Texas. In 1984 the name changed to "The Music Festival." In 1989 it went national and the name was changed to "The National Veterans Creative Arts Festival." By 2005, there were five creative arts divisions – Art, Music, Dance, Drama and Creative Writing. 2019 saw nearly 3,600 Veterans from 130 VA Medical Facilities join in the Festival. The 2022 Festival is scheduled for April 20-25 in St. Petersburg, FL.

Veterans are eligible to participate if they receive medical care through the Department of Veterans Affairs and are enrolled at a VA Medical Center, Outpatient Clinic or Veterans Center before their LOCAL competition. Look into this at your local VA and see if you can help. And if you do look into it, please, please, please send me a report.

At the time of this writing, the results of the Department of New York **Voice of Democracy** and **Patriot's Pen Scholarships Program** have not been announced. Please remember that **Recognition Is Key!!** It is important that Scholarships Contest Winners receive recognition at every level. There are many ways to recognize winners: certificates, host an awards ceremony, present awards at a school assembly, contact local media or invite winners to a Conference. Don't forget to also recognize their parents and teachers.

<u>Continuing Education Scholarship</u> – This scholarship is open to only VFW Auxiliary members, their spouses and children. The two qualifications are: 1.) The Auxiliary member whom the applicant is applying under must have been an Auxiliary member at least one year and 2.) The applicant must be at least 18 years of age. One winner in each of the (4) four conferences will receive a \$1,000 scholarship.

<u>Young American Creative Patriotic Art Contest</u> – This VFW Auxiliary's Patriotic Art scholarship has been awarded for the last 42 years to students in grades 9-12. This year there are 12 National awards totaling \$33,000. The first-place winner will receive a \$15,000 scholarship. Since Sammy nor Dora won their essay contests, Sammy is working very hard on his painting for the **Young American Patriotic Art** entry. Hope he finishes and has it to his local Auxiliary by the <u>due date of March 31, 2022</u>.

Our National President Jean Hamil has created the Young American Creative Patriotic Art Contest Escrow Fund. Help us recognize <u>more</u> students by sending a personal donation or a donation from your Auxiliary. Ask if you can display a small poster and donation jar at your Post's next function. Include the mailing and website address for National Headquarters and also contact information for your local Auxiliary.



We made contact with the viewers husband and we were able to deliver Christmas Trees to him while he was deployed in Kuwait. In 2020 he was in Abu Dhabi and again we were able to get Christmas Trees to his Air Force Squadron. This year he is stateside, but his wife Carol Ann serves as a "Key Spouse" for units deployed overseas. We were again able to get Christmas Trees delivered to the 302ndAirlift Wing currently deployed in Abu Dhabi.
