#### <u>NATIONAL OFFICIAL RULING ~ JANUARY 14, 2025</u> PROPERTY OWNERSHIP

At the 2024 VFW Auxiliary National Convention in Louisville, Kentucky, the VFW Auxiliary National Bylaw, Article IX, Sec. 920 – Property Ownership was passed. To resolve any confusion, I have made this official ruling on the interpretation of this Bylaw.

As stated in Sec. 920, B., For the purposes of these Bylaws, personal property is defined as tangible and intangible property that is moveable, even if a small amount of disassembly is required to move. C., For the purposes of these Bylaws, real property is defined as land and permanent structures on the land. Therefore, be it known that:

• Auxiliaries may own personal property, per Sec. 920, A.

• When personal property is placed in a VFW Post building, there shall be a clear understanding of who owns the property, how it will be used and disposed of if the VFW Post and/or VFW Auxiliary goes defunct.

• This understanding shall be in writing and signed by both the VFW and the VFW Auxiliary.

• Any items without a clear, signed statement of ownership and usage, will be the property of the VFW Post.

• Items donated to the VFW Post prior to the Bylaw change, are the property of the VFW Post, unless there is a previously signed document stating otherwise.

• Additionally, the Auxiliary may not charge the VFW Post rent to use items purchased by the Auxiliary that are kept at the VFW Post building (e.g., tables, chairs, etc.), unless a written agreement exists between the VFW Auxiliary and the VFW Post for the rental of these items.

• Any shed or building purchased by the Auxiliary and placed on the VFW Post property shall belong to the VFW Post and not the Auxiliary. The VFW Post as owner pays the taxes and insurance on such property. Any ad valorem tax or any other taxes are the responsibility of the owner of the property.

• The exception to this is that Auxiliary specific and/or Auxiliary branded items (e.g., Auxiliary Charter, Auxiliary Flags, Color Bearer Flags, Auxiliary Banners, Auxiliary Plaques, Auxiliary Awards, etc.) remain the property of the Auxiliary.

The goal is teamwork. We encourage all VFW Auxiliaries and VFW Posts to work together. Clear communication is the key.

All officers assume their duties upon the installation of the Department President in June, EXCEPT the Auxiliary Secretary and Auxiliary Treasurer, who do not assume their duties until the beginning of the fiscal year, July 1<sup>st</sup>, when their "Duties" tab will then be set in MALTA after the annual reset.

I mentioned in the last issue that the Memorial Book will be based on the information in MALTA from June 1, 2024-May 31, 2025. Your Auxiliary can enter these yourself and if you do, I don't need the Change form sent to me.

I recently entered six deceased life members and came to an unpleasant realization that I feel the need to share with you. Some of these had been deceased for as long as 7 years, others between 3-5. Since these were life members, the Auxiliary was still collecting the Life Member rebate from National all those years. At the current rate, that would have been over \$76.00 in total. This was just one Auxiliary, in one Department. Imagine how many there must be in the National organization! This is essentially theft, collecting money we are not entitled to. We lament the rising cost of membership yet collectively contribute to it. The amount of money National must be paying for members who are in their Heavenly Homes must be in the thousands of dollars. I began to wonder to myself if the time could come when National could ask Auxiliaries to pay back money received for members who have been deceased for years. I think it's something to think about and beseech all Auxiliaries to do the honorable thing and enter your deceased members in a timely manner.

In conclusion, I hope all your year-end reports have been submitted and I see you at the Department Convention receiving your rewards and recognition for all the work you do each and every year for our Veterans and this Organization. I know most of us do not like to "blow our own horn," but it's how others who could be eligible learn about us, about what we do, and want to become part of us. So, BLOW THAT HORN LOUDLY!

As you assume the role of an officer or chairman, please be aware there are many helpful resources available to guide you. All members, especially officers and chairmen, should have a current Podium Edition and Bylaws and Ritual. The Podium Edition may be purchased from the VFW Store (Online at vfwstore.org or telephone: 833-839-8387). The digital version of the 2025 Podium Edition can be found on MALTA  $\rightarrow$  Member Resources, where it can also be downloaded.

Begin your term by familiarizing yourself with **Bylaws Sec. 801**. This section contains an overview of the duties and responsibilities for all elective and appointive officers. "The Booklet of Instructions" is also known as the "yellow pages" because the pages are printed on yellow paper! There is much valuable information found on these pages. You may wish to review "Election of Officers," Election Procedure, Two (2) or More Candidates" and "Election by Acclamation, One (1) Candidate" prior to your April Auxiliary meeting!

An Auxiliary NOT current with audits, **is not** eligible to vote at District or Department Conventions. An Auxiliary behind **two or more quarterly audits** may be placed on Suspension until audits are completed. We are ALL here to help each other. If you have a question or are unsure about something, *PLEASE* contact me. If I do not have the answer, I will find someone who does!

I remind all Auxiliary Presidents to complete the **R U Healthy? Auxiliary To-Dos and Deadlines** checklist and return to me no later than May 15, 2025. The checklist was in the President's packet from June, 2024. If you require a copy, you will find a copy of the form on the Department website under **Programs**  $\rightarrow$  **Extension & Revitalization**  $\rightarrow$  **R U Healthy Checklist form 2024-2025**. The right claw of the eagle clutches an olive branch and the left thirteen arrows signifying "the power of peace and war." The red and white stripes on the eagle's breast reminds Americans to rely on their own virtue. The blue field in the shield represents the president and congress being represented by the states, denoted by the red and white stripes. **Red** - hardiness and valor; **White** - purity and innocence; and **Blue** - vigilance, perseverance, and justice. Above the eagle's head.in a field of blue is a constellation formed of thirteen stars. America, a new state, was taking its place among other nations. You may not have noticed but thirteen is repeated many times in the Great Seals components. Even the motto *E pluribus unum* has thirteen letters.




