
Who is impacted?


FY 2023 Ohio VFW Electronic Pull-Tab Revenue



What does MODERN CHARITABLE GAMING look like? (Electronic) Bell Jar Tickets


- As each electronic game is played, a preprinted paper ticket with symbols matching the on-screen game is dispensed below the button deck.
- The device tracks player balances.
- A redemption ticket is printed when a player cashes out.

WHAT THE COMPARISON OF PAPER & ELECTRONIC BELL JAR TICKETS LOOK LIKE



Paper Bell Jar Tickets	Electronic Bell Jar Tickets	
Contains a set of <u>finite</u> and predetermined number of tickets	Contains a set of <u>finite</u> and predetermined number of tickets	
Has a defined payout	Has a defined payout	
Winners & losers are predetermined by the manufacturer	Winners & losers are predetermined by the manufacturer	
Charity has a guaranteed profit of a predetermined amount	Charity has a guaranteed profit of a predetermined amount	
Tickets are dispensed from a container by a seller upon request of a player	Tickets are revealed on the device upon request of a player (button press)	
Seller has no effect on who wins or loses	Device has no effect on who wins or loses (all predetermined)	
Players compete against each other to win the predetermined prizes in the game	Players compete against each other to win the predetermined prizes in the game	
Winning or losing symbols are identified on the ticket	Winning or losing symbols are identified on the ticket	
Winning tickets are redeemed for prizes	Winning tickets are redeemed for prizes	
Charity manually counts tickets sold, and manually reports proceeds	Device digitally records tickets sold, and configures reports for submission
